#### BOOTH RESERVATIONS:

Advertising and promotions begin mid-summer and last up until the event.

**NO FEE** is required for booth reservation and participation. In exchange, vendor agrees to supply small appetizers or small bites to 300-500 guests during the event. (Guest count will range anywhere between 300 up to 500 guests. A specific head count will be provided to you one week before the event.)

**Reimbursement for food is available to vendors who qualify. Please contact us for more information.**

#### BOOTH SPACES:

All booth spaces measure approximately 10'x10'.

All booth spaces include one 8' table and linen.

Plates and napkins will be supplied by event organizer (MVA), vendor does not need to supply.

Vendor must supply utensils, if needed.

Vendor must supply extension cords and power strips, if needed.

Booths are set up both indoors and outdoors for this event. Vendor must bring their own pop up tent if desired.

Vendor may set up additional advertising banners and materials.

#### BOOTH SET-UP: Your cooperation with the following is critical to a successful event

Check-in and set up begins at **3:30 PM** and booths must be completely set-up by **5:30 PM**. Vehicles can be driven up either to the front doors of the winery or to the side of building to unload near the back patio/garden area, and then must immediately be parked in the main lot. All vehicles must be completely moved and parked in the main parking lot by 5:30 PM. All vendors must remain at booths until the close of the event at 9:00 p.m.
